# LODI AREA HOMESCHOOL ORGANIZATION MEMBERSHIP POLICY

## **Membership Policy for Leadership**

The Lodi Area Home School Organization (LAHSO) will be led by a "Steering Committee". The Steering Committee consists of volunteer parents with a servant-leadership heart.

The Steering Committee will be responsible to uphold the following:

- Seek God first for wisdom in leadership: I Chronicles 16:11 "Look to the Lord and his strength; seek his face always."
- Lead in humility: Philippians 2:3-4 "Do nothing out of selfish ambition or vain conceit. Rather, in humility value others above yourselves, not looking to your own interests but each of you to the interests of the others."

 Be the final decision maker on matters of the group. This group is a Co-op; however, leadership is required to make the group function. The Steering Committee will listen to concerns, pray for wisdom, and come to a conclusion. The Steering Committee has the authority to make final decisions that they feel are most profitable for the group as a whole.

#### **Membership Policy for Members**

LAHSO is a Co-op made up of families who wish to offer special subjects to our children. Members will be required to participate in some manner to contribute to the group.

Membership will be responsible to uphold the following:

- Honor and respect the leadership: I Thessalonians 5:12-13 "We ask you, brothers, to respect those who labor among you and are over you in the Lord and admonish you, and to esteem them very highly in love because of their work." Be at peace among yourselves."
- Attend the following 3 mandatory classes: music, gym, and an enrichment class that will
  provide a variety of courses such as art, science, etc. Extenuating circumstances can be
  discussed with the Steering Committee.
- Adhere to the Membership Policy. Parents and children will be required to read and sign the Membership Policy so that all parties understand their commitment and responsibilities.
- Contribute to the operations of LAHSO. We understand all people are not gifted teachers, but there are many different opportunities for parental participation. All parents will be required to help in at least one class. Contact a Steering Committee member if unsure how to participate.
- Be present at group. Parental presence is required for members of LAHSO. If sickness or an appointment occurs, special arrangements can be made with another parent to take charge over your children. Communication must be made to the Steering Committee. Extenuating circumstances of parental absence can be discussed with the Steering Committee.

### **Membership Policy for Dress**

Students and adults shall dress modestly at all LAHSO functions.

- Skirts, dresses, and shorts should not be short, but rather modest.
- Girls wearing skirts or dresses must consider modesty if a Phy. Ed. or similar activity is involved.

- Shirts should not contain profanity, vulgarity, or any questionable graphics.
- Outer garments should cover under garments easily and completely.
- Shoes or tennis shoes (not sandals or boots) should be worn for gym.

Failure to follow the Membership Policy for Dress will result in the teacher in charge having a discussion with the student and/or the parent, whichever seems more appropriate.

## **Membership Policy for Social Conduct**

At any group function, adults and students will conduct themselves in keeping with Biblical values and the highest of personal character and virtue.

There should be no inappropriate or intimate conversations or physical contact between students and/or adults anywhere on the premises or at any LAHSO sponsored activity. The adults present will determine inappropriate or intimate.

## **Membership Policy for Teachers and Curriculum Selection**

Any parent or guardian shall consistently attend the group for at least 4 months prior to teaching a class on a regular basis. This does not include assisting. If necessary, exceptions could be made by the LASHO Steering Committee to these stipulations.

New teachers or those teaching a different class or age level should provide a brief oral or written outline or sample of the curriculum prior to the start of classes for approval by the LAHSO Steering Committee. Teachers who are teaching a class they have previously taught need only provide an outline upon request of a parent and/or the LAHSO Steering Committee.

### **Membership Policy for Attendance**

Since LAHSO is by definition a Co-op, it functions well only with commitment from its members. Therefore, regular attendance is extremely important. To this end, we will be taking and recording attendance every week. It is also important to arrive 5-10 minutes before the official start time so classes can begin on time.

If you have any planned absences, please contact the Steering Committee via lahsogroup@gmail.com, as soon as possible. It is your responsibility to find a substitute for all classes you are helping with.

We understand some absences, such as sick family members and emergencies cannot be predicted or prevented, but, if possible, please limit other absences to ones that cannot be avoided.

### **Membership Policy for the Facility**

The Lodi Community Center is the facility that LAHSO has been allowed to meet at. The group is blessed to have such a wonderful facility. We are expected to maintain proper, respectful behavior when at the facility.
